Nursery is closed on all Bank Holidays and for a week at Christmas. You are not charged for these days. Your monthly fees are calculated by multiplying your weekly fee by 51 and dividing that into 12 monthly payments.

Payment of fees is by Direct Debit, but we also accept Early Years Funding, Tax Free Childcare payments and NHS Tax Efficient Childcare payments

Early Years Funding

From September 2025, eligible families can claim up to 1140 funded hours each academic year (often advertised as 30 hours a week over 38 weeks)

As we stretch your 1140 funded hours over the full year (51 weeks) you can receive up to approximately 22.35 hours per week. We then charge for any additional hours or days over your funded hours.

The onus is on parents to reconfirm their eligibility via HMRC every 3 months when prompted to do so.

Enhanced Provision Charge (EPC)

We request that parents pay the Enhanced Provision Charge for meals, snacks, plus a variety of enrichment activities, that are not covered in the funding we receive.

Additional Information

All fees are payable in advance and due by the first day of the month.

Our primary method of payment is by Direct Debit which will leave your account in the first week of the month

Overtime Charge is £21.25 per quarter or part quarter hour, payable for the late collection or early arrival of a child outside of allocated session times

*£8.50 surcharge for swapping your normally attended day

*Terms and conditions apply

£45.00 surcharge applies on late payment of fees or failed Direct Debit due to insufficient funds

£15.00 surcharge applies on failure to set up a Direct Debit or cancellation of the mandate or monthly fees

Parents wishing to pay by Tax Free Childcare must sign our TFC Agreement and agree that payment be received by Daisy Chain Day Care by the last day of the month before due date

Minimum notice requirements apply, and fees are subject to review in accordance with the Parents Agreement
