

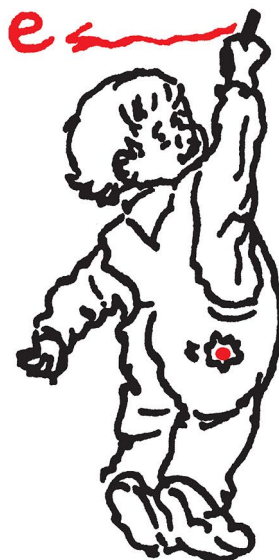
# daisy chain daycare

## Daisy Chain at Wrekin Prep - Nursery Fees from September 1<sup>st</sup>, 2025

1 non-funded day Full Year is £69.00 per day  
1 non-funded day Term Time is £75.90 per day  
A day is anytime between 7.30am and 6.00pm and includes lunch, afternoon tea and a snack

1 non-funded short day Full Year is £58.50 per day  
1 non-funded short day Term Time is £64.35 per day  
A day is anytime between 8.00am and 3.30pm and includes lunch, and a snack

Nursery is closed on all Bank Holidays and for a week at Christmas. You are not charged for these days. **Full Year** monthly fees are calculated over the full year and divided into 12 monthly payments. **Academic Year** monthly fees are calculated over the full academic year and divided into 10 monthly payments, September to June inc.



### Early Years Funding

From September 2025, eligible families can claim up to 1140 funded hours each academic year (often advertised as 30 hours a week over 38 weeks)

For **Full Year** children, we stretch your 1140 funded hours over the full year (51 weeks) so you can receive up to approximately 22.35 hours per week. We then charge for any additional hours or days over your funded hours. The onus is on parents to reconfirm their eligibility via HMRC every 3 months when prompted to do so.

### Enhanced Provision Charge (EPC)

We request that parents pay the Enhanced Provision Charge for meals, snacks, plus a variety of enrichment activities, that are not covered in the funding we receive.

Please refer to our Working Parents Entitlement information sheet for more details. Our current EPC are as follows:

Full Day Meals & Snacks (per funded day)	£7.00	£8.25
Short Day Meals & Snacks (per funded day)	£4.50	£5.75
IT & Care Package (per funded day)	£3.50	£3.00
Enhanced Provision (per week)	£2.75	£8.25
A weekly total EPC for 2 full days would be	£23.75	£30.75
A weekly total EPC for 2 short days would be	£18.75	£25.75

### Stretched Funding for Eligible Working Families – September 1<sup>st</sup> 2025 to August 31<sup>st</sup>, 2026

Example estimates of weekly fees inclusive of the EPC for a child attending for a **Full Year** starting September 1<sup>st</sup> 2025.

2 Days	£30.20	£37.20
3 Days	£84.54	£91.54

### Additional Information

All fees are payable in advance and due by the first day of the month.

Our primary method of payment is by Direct Debit which will leave your account in the first week of the month

Overtime Charge is £20.00 per quarter or part quarter hour, payable for the late collection or early arrival of a child outside of allocated session times

£69.00 surcharge for an extra day and there is \*£8.00 surcharge for swapping your normally attended day \*Terms and conditions apply

£45.00 surcharge applies on late payment of fees or failed Direct Debit due to insufficient funds

£15.00 surcharge applies on failure to set up a Direct Debit or cancellation of the mandate or monthly fees

Parents wishing to pay by Tax Free Childcare must sign our TFC Agreement and agree that payment be received by Daisy Chain Day Care by the last day of the month before due date

Minimum notice requirements apply, and fees are subject to review in accordance with the Parents Agreement
